The total offered contract price is **EUR 2,402,673.70** without VAT in the Republic of Serbia i.e. RSD 282,733,186.04 at the official selling exchange rate of the National Bank of Serbia on the date that is 10 days before the date set for the opening of bids (1 EUR = 117.6744 RSD).

### JUSTIFICATION

### 1. SUBJECT AND ESTIMATED VALUE OF PROCUREMENT

The subject of procurement are the works - Construction of the building and supply infrastructure for the needs of Terminal Area Radar (TAR) Belgrade.

The name and designation from the Common Procurement Vocabulary (CPV): 45000000-7 Construction Works.

The estimated value of the procurement is RSD 283,200,000.00 excluding VAT which is levied in the Republic of Serbia.

Procurement is foreseen in the Contracting Authority's Plan for Procurement to which the Law on Public Procurement of the Republic of Serbia does not apply, No. NAB.00-80/205 dated 18/10/2022 under point 16. Construction of the building and supply infrastructure for the needs of Terminal Area Radar (TAR) Belgrade, and is initiated in accordance with the Request for Initiating the Procurement Procedure, No.9311/1-2022 dated 18/10/2022. The funds for the procurement in question have been secured from euro loan financing, in accordance with the Finance Contract concluded with the European Investment Bank (hereinafter referred to as "the Bank"), No. SUS.00-65/567 dated 25/04/2018 (hereinafter referred to as "Finance Contract"), component under the point 2.7 of Schedule A that constitutes integral part of the Finance Contract.

The official selling (foreign) exchange rate of the National bank of Serbia, applicable on date that is 10 days before the date set for the opening of bids is EUR 1 = RSD 117.6744.

### 2. TYPE AND METHOD OF IMPLEMENTATION OF THE PROCUREMENT PROCEDURE

The Contracting Authority has implemented an international open procedure procurement in accordance with the rules established by the Bank's Guide to Procurement for projects financed by the Bank, in accordance with Article 11, paragraph 1, point 2, of the Law on Public Procurement ("Official Gazette of the Republic of Serbia", No. 91/91) and in accordance with the Finance Contract.

The procedure was initiated by the Decision on conducting the Procedure, HUM.00-65/251 dated 19/10/2022.

The Contracting Authority received a no further comments letter via e-mail from the Bank regarding the Tender Documents on 16/11/2022 (the document is registered under number SUS.00-65/263 dated 16/11/2022).

The International Invitation for Bids was published on 23/11/2022 in the "Official Journal of the European Union" and on the Contracting Authority's homepage, and in the "Official Gazette of the Republic of Serbia", on 25/11/2022. The deadline for the submission of bids was 10/01/2023 until 10:00 a.m.

The number of potential bidders who have purchased the Tender Documents is six (6).

#### 3. RECEIPT AND OPENING OF BIDS

The procedure for the opening of bids was carried out at the premises of the Contracting Authority's headquarters at 10 Nikola Pašić Square, Belgrade, immediately upon the expiry of the deadline for the submission of bids, on 10/01/2023, at 10:30 a.m., whereof the Minutes of the Bid Opening was prepared, No. SUS.00-65/2 dated 10/01/2023.

Within the deadline, which was 10/01/2023, at 10:00 am, one (1) bid was received at the seat of the Contracting Authority's address, as follows:

There were no untimely bids.

The bid opening was public. There were no Bidder's representatives present.

# 4. DETECTED CONFLICT OF INTERESTS AND SUBSEQUENT MEASURES TAKEN IN THAT REGARD

No conflict of interest was detected in the respective procedure.

# 5. DETERMINATION OF RESPONSIVENESS OF BIDS

The Procurement Committee conducted the expert evaluation of bids in order to determine whether the delivered bids meet the requests from the Tender Documents, according to point (24), Chapter VI of the Tender Documents.

5.1. Joint Bid: JADRAN DOO BEOGRAD, ABA PROFESSIONAL DOO BEOGRAD, TVI DOO BEOGRAD, INSTITUT MIHAJLO PUPIN DOO BEOGRAD, KONVEREKS DOO BEOGRAD, MLS EXING DOO BEOGRAD, with the subcontractor ELEKTROMONTAŽA DOO KRALJEVO, No. SUS.00-65/3 dated 10/01/2023 (hereinafter referred to as: "the Bid")

In the course of the expert evaluation of the Bid, the Procurement Committee established the following facts:

- 1. The bid was timely, submitted on 10/01/2023, at 09:15 a.m., before the deadline for the submission of bids:
- 2. When submitting bids, the bidder submitted required forms proving the fulfillment of the required criteria for qualitative selection of the economic entity, from Chapter II of the Tender Documents. In the expert evaluation procedure, in accordance with item (26) i. Chapter VII of the Tender Documents, with Request no. SUS.00-65/7 dated 13/01/2023 the Procurement Committee required from the bidder to submit the evidences of fulfillment of the criteria for qualitative selection of the economic operator. The bidder has proven that it meets the following criteria for the qualitative selection of the business entity, as follows:

## 2.1. Grounds for exclusion:

- that it and its legal representative in the period of the previous five years from
  the expiration of the deadline for submission of tenders, have not been
  convicted, unless the final judgment establishes another period of prohibition
  of participation in the procurement procedure, for the required criminal offense,
  and also that it has paid the due taxes and contributions for compulsory social
  insurance or that it has been granted a deferral of debt payment, including all
  accrued interest and fines, by a binding agreement or decision, in accordance
  with a special regulation;
- that in the period of the previous two years from the expiration of the deadline for submission of the tenders, it has not violated the obligations under the Labor law in application of social and labor law, including collective agreements, and in particular the obligation to pay contracted wages or other compulsory payments, including obligations and national and international standards in the field of environmental protection, health and safety, as well as those contained in any relevant International Labor Organization (ILO) convention, and international agreements on environmental protection, and obligations in accordance with the provisions of international conventions listed in Annex 8 of the Law on Public Procurement
  - by submitting the appropriate Excerpts from the Register of Bidders maintained by the Business Registers Agency of the Republic of Serbia, for all members from the joint bid and for the subcontractor;
- that there is no conflict of interest, in terms of the Law on Public Procurement, which cannot be remedied by other measures, as well as that there is no conflict of interest in accordance with Article 1.5 of the Bank's Procurement Guide, which stipulates that a conflict of interest exists when a situation arises in which the Contracting Authority's impartial and objective functions or respect for competition principles, prohibition of discrimination or equal treatment in the procurement procedure, or in performance of contracts, are jeopardized for reasons involving family members, emotional life, political affiliation or nationality, economic interests or any other common interests. The concept of conflict of interest covers any situation in which the employees of the Contracting Authority who are involved in the conduct of the procedure or may influence the outcome of the procedure, have a direct or indirect, financial, economic or other personal interest that may be considered to compromise their impartiality and independence in the context of the procurement procedure, or performance of the contract;
  - ✓ by submitting the appropriate Statement on the absence of conflict of interest - FORM IV-3, for all members from the joint bid and for the subcontractor;

- that it did not try to exert an inappropriate influence on the decision-making
  process of the Contracting Authority, or to obtain confidential information that
  could give it an advantage in the procurement procedure, or that it did not
  provide misleading information that may affect decisions concerning the
  exclusion of the business entity, the selection of the business entity or the
  award of a contract
  - ✓ by submitting the appropriate Statement on the fulfilment of the criteria for the qualitative selection of the economic entity - FORM IV-6, for all members from the joint bid and for the subcontractor;
- that neither it, nor anyone, including its directors, employees, agents or subcontractors, if any, acting on his behalf with the appropriate authorization or with the knowledge or consent, or with its support, is not involved, nor will be involved in any illegal actions (as defined by the Bank) in connection with the procurement procedure or in the performance of any works, delivery of goods or performance of services, for the Procurement Construction of the building and supply infrastructure for the needs of Terminal Area Radar (TAR) Belgrade and that he undertakes to notify the Contracting Authority if any person from its organization responsible for ensuring compliance with this Statement, becomes aware of any such illegal actions
  - ✓ by submitting the appropriate Statement of Integrity FORMI V-4, for all members from the joint bid;

- 3) a valid authorization for design and execution of fixed fire extinguishing systems (License B1) and authorization for design and execution of fixed fire alarm systems (License B2), issued by the competent authority: Ministry of Interior of the Republic of Serbia - Sector for Emergency Situations, Directorate for Preventive Protection, in accordance with the current Law on Fire Protection of the Republic of Serbia;
  - ✓ by submitting the appropriate authorization for the group member TVI DOO BEOGRAD;
- 4) a valid decision of the competent authority the Republic Geodetic Authority, on performing the activity which is the subject of procurement, in accordance with the Rulebook on license for work of a geodetic organizations and geodetic license, "Official Gazette of the Republic of Serbia", Nos. 33/10 and 2/15), and/or a valid license for the work of a geodetic organization, for the preparation of the technical document for

geodetic works and professional supervision of geodetic works, for which the development of a Master Design is planned, as well as geodetic marking projects in the field of urban planning, execution of geodetic works for which the Master Design is planned, execution of geodetic works in the process of maintaining the real estate cadaster and maintaining the cadaster of overhead lines, as well as execution of geodetic marking projects in the field of urban planning and production of geodetic bases in engineering and technical areas that do not require a Master Design,

✓ by submitting the appropriate decision of the competent authority for the group member ABA PROFESSIONAL DOO BEOGRAD;

## financial and economic capacity:

- that it does not have recorded days of blocked accounts, in the period of 12 months before the publication of the International Invitation for Bids
  - ✓ The Committee determined the fulfilment of this criterion, for all members from the joint bid and for the subcontractor, because the evidence is publicly available on the website of the competent authority - National Bank of Serbia
- that it has generated a total operating income in the amount of at least the equivalent of to the double amount of the estimated value of the procurement, in the previous three accounting years (2019, 2020 and 2021),
  - ✓ by submitting the appropriate Income statements with the auditor's reports on the performed audit of the annual financial report for each required year (2019, 2020 and 2021) of the group member JADRAN DOO BEOGRAD;

## · technical and professional capacity:

- that it has engaged in any manner provided by the Labor Law, graduate engineers of appropriate professions, who will be appointed as responsible contractors for the execution of works and execution of the contract, as follows:
- one graduated engineer of architecture with a valid license 400 Responsible contracting engineer for architectural projects, open space planning and internal water-supply and sewerage installations and/or valid 401 licences – Responsible person for the performance of works on architectural and construction structures and construction and craftsman works on construction facilities issued by the Chamber of Engineers of Serbia;

- 4,800,000,00, of which one facility must be in the value of at least EUR 2,400,000.00;
- ✓ by submitting the appropriate Certificate Form IV-7-3 for the subcontractor ELEKTROMONTAŽA DOO KRALJEVO;
- that the bidder is authorized by the manufacturer (or a distributor authorized by the equipment manufacturer to authorize other entities) of the offered UPS device for bidding, delivery, installation and commissioning,
  - ✓ by submitting the appropriate UPS device Manufacturer's Certificate for the group member KONVEREKS DOO BEOGRAD.
- that the bidder is authorized by the manufacturer (or a distributor authorized by the equipment manufacturer to authorize other entities) offered generators for bidding, delivery, installation and commissioning.
  - ✓ by submitting the appropriate Generator Manufacturer's Certificate for the group member MLS EXING SOO BEOGRAD,
- that at the moment of submitting the Bid, the Bidder has at his disposal (that he is the owner or that he has leased) required fully operational heavy equipment vehicles and machinery,
  - ✓ by submitting the appropriate evidence (Photocopies of vehicle registration document and valid vehicle insurance policies, photocopies of valid expert report on the performed inspection and testing of the equipment where requested and photocopies of calibration certificates where requested) from the group member JADRAN DOO BEOGRAD.
- that the Bidder has, over the period of 3 years prior to the deadline for submission of bids, performed for the previous Buyers/Investors – entities for which the facility was constructed and in the name of which the construction permit was issued - the works on construction of a minimum one cable line of more than 5 km;
  - ✓ by submitting the appropriate Certificate Form IV-7-4 for the subcontractor ELEKTROMONTAŽA DOO KRALJEVO.
- 3. The Bidder offered the validity period of the bid in accordance with the requirements of the Tender Documents 150 days following the bid opening date;
- 4. Other forms and required documents were submitted:
  - Bid Form IV-1,
  - Form IV-1a Bid Form for all members from the joint bid;
  - Form IV-1b Bid Form for the subcontractor:
  - Price structure Form IV-2.
  - Model Contract from Chapter V,
  - Bid Bond,
  - Card with deposited signatures.
  - Agreement from Chapter VII, and
  - Copy of the bid and electronic version of the Bid in PDF format on a USB stick;
- 5. There are no valid evidence of distortion of competition or corruption;
- 6. There are no identifies shortcomings due to which it is not possible to determine the actual content of the offer;
- 7. Price offered: The total offered price amounts to EUR 2,402,673.70 excluding VAT in the Republic of Serbia, which amounts RSD 282,733,186.04 excluding VAT in the Republic of Serbia, which is within the range of the estimated value (RSD 283,200,000.00).

#### 6. CONTRACT AWARDING CRITERION

The criterion for awarding the contract or bid evaluation is the lowest total bid price listed in the Bid Form.

Following the review and expert evaluation of the bids, the Procurement Committee, having applied the award criteria, determined that one acceptable bid has been obtained:

### 7. THE BIDDER TO WHOM THE CONTRACT IS AWARDED

The Procurement Committee states that the group of bidders JADRAN DOO BEOGRAD, Anrija Žamea 4, 11060 Belgrade, ABA PROFESSIONAL DOO BEOGRAD, Heroja Nebojše Živančevića 6A, Belgrade, TVI DOO BEOGRAD, Bitoljska 23, Belgrade, INSTITUT MIHAJLO PUPIN DOO BEOGRAD, Volgina 15, Belgrade, KONVEREKS DOO BEOGRAD, Batutova 7/I, Belgrade and MLS EXING SOO BEOGRAD, Trstenjakova 3, Belgrade, with the subcontractor ELEKTROMONTAŽA DOO KRALJEVO, Aerodromska 7, 36000 Kraljevo, in the conducted procedure proved that there are no grounds for exclusion, that the criteria for selection of the business entity are met, and that the bid registered with Contracting Authority under registry no. SUS.00-65/3 dated 10/01/2023, is acceptable and within the estimated value.

Share of contract to be performed by the subcontractor ELEKTROMONTAŽA DOO KRALJEVO refers to part of the electrical works, in the percentage of 1% of the total value of the procurement.

The value of the contract (total offered price) is 2,402,673.70 euros without VAT in the Republic of Serbia.

Therefore, bearing in mind all stated, including non-objection letter from the Bank, register No. SUS.00-65/41 dated 21/02/2023, the Contracting Authority awards the Contract to the stated Group of Bidders, in accordance with the Article 146. of the Law on Public Procurement of the Republic of Serbia ("Official Gazette of the Republic of Serbia", No. 91/19) and the Guide to Procurement for Projects financed by the European Investment Bank.

## **INSTRUCTION ON LEGAL REMEDY:**

Against this decision, a request for protection of rights may be submitted within 10 (ten) days from the day of receipt of this decision, pursuant to Article 214. Paragraph 3. of the Public Procurement Law of the Republic of Serbia ("Official Gazette of the Republic of Serbia", No. 91/19) and Article 2. of the Amendment Agreement in Relation to the Finance Contracts

23.761, 24.745, 25.002, 25.198, 25.497, 25.610, 25.872, 81.657 and 82.640, concluded between Republic of Serbia and the European Investment Bank ("Official Gazette of the Republic of Serbia – International treaties", No. 11/17 and "Official Gazette of the Republic of Serbia", No. 67/19 – Authentic interpretation of the Law).

The request is to be submitted electronically to the Contracting Authority and the Republic Commission for Protection of Rights in Public Procurement Procedures, or in writing, by direct delivery or registered mail to the Contracting Authority, in which case the applicant is obliged to copy request for submission to the Republic Commission.
