Additionally, apart from visual sensors, CCTV system will consist of a number of thermal cameras, which are able to provide recognition of the objects on the runway or manoeuvring areas during night or in case of low visibility. Central part of the CCTV system is project specific (custom made) HMI, providing integral control and supervision.
